Please retain this copy of the Lesson & Tuition Agreement for your records.

- 1. All tuition is **due monthly** during the first week of each month. Tuition is required at registration to reserve your space. A \$10 late fee may be applied to any tuition balance not paid by the 10th of each month. All tuition is **non-refundable**.
- 2. CMA must be notified **no less than 24 hours** in advance of a lesson cancellation in order for it to be considered and excused absence. Excused lessons have 3 months to schedule a make-up lesson with their instructor. No make-ups are given for any group classes.
- Any cancellation that is not made at minimum 24 hours in advance may be considered an unexcused absence, at the discretion of CMA. No-call/no-show lessons are considered unexcused, and cannot be made-up.
- 4. CMA must be notified in advance of any vacation days the student will be taking.
- 5. It is the responsibility of the person paying the tuition to inform CMA in writing that the student is discontinuing lessons. This written notice must be given to the front desk. The student will continue to be billed for lessons until the written notice has been received.
- 6. CMA reserves the right to utilize a qualified substitute teacher when necessary.
